The meeting was called to order at 6:02 P.M. by Superintendent Pam Vogel. The first item of business on the agenda was Election of Officers.

Nomination by Deborah Rathbun/2<sup>nd</sup> by Kathleen Visconti of Doug Cahill as Board Chairman. Motion by Amanda Thompson/2<sup>nd</sup> by Monica Connor that nominations cease. Doug Cahill was elected Board Chairman by unanimous vote.

Chairman Doug Cahill assumed leadership of the meeting at this time.

Nomination by Deborah Rathbun/2<sup>nd</sup> by Monica Connor of Kathleen Visconti as Board Vice-Chair. Motion by Monica Connor/2<sup>nd</sup> by Anne Vance that nominations cease. Kathleen Visconti was elected Board Vice-Chair by unanimous vote.

Nomination by Amanda Thompson/2<sup>nd</sup> by Monica Connor of Deborah Rathbun as Board Secretary/Treasurer. Motion by Anne Vance/2<sup>nd</sup> by Monica Connor that nominations cease. Deborah Rathbun was elected Board Secretary/Treasurer by unanimous vote.

Superintendent Vogel gave a brief review of both her November report and the Assistant Superintendent's report. She will give a presentation about her China trip at the next Board meeting.

The 9000 series had its first reading. The vote to adopt this series of policies will take place at the December meeting.
