The meeting was called to order at 6:01 p.m. by Board Chair Doug Cahill

Motion by Amanda Thompson/2<sup>nd</sup> by Deborah Rathbun to approve the agenda as presented. Motion carried by unanimous vote.

Principal Manning informed the Board that May 7 was "School Nutrition Hero Day". She recognized and thanked Andrea Wilson, cafeteria manager, and Debbie Anderson, cafeteria assistant, for their dedicated work providing meals for the students at Sharon Center School during the Covid-19 pandemic.

During "Spotlight on Student Learning", Superintendent Lisa Carter recognized the CAS Scholar Leaders Leo Cajilima and Olivia Peterson.

She also recognized the Litchfield County Superintendents' Award winner, Charlotte Smith.

Motion by Anne Vance/ $2^{nd}$  by Amanda Thompson to accept the Consent Agenda as presented. Motion carried by unanimous vote.

No Public Comment was heard.

Principal Manning gave a brief report, beginning with a Power Point Presentation of recent activities at Sharon Center School.

She told the Board about the successful Kindergarten registration and informed them that an outdoor graduation ceremony will take place on Wednesday, June 16, with a rain date of Friday, June 18. The ceremony will be limited to graduates and their families (4 guests for each graduate).

She also told the Board that Brian Kenny is organizing a Memorial Day parade and ceremony, with Charlotte Smith singing the National Anthem and Savanah Milton playing Taps.

The Town Budget Vote will take place at 6:30 P.M. on Friday, May 14, 2021 here at the school.

The Assistant Superintendents reviewed their May reports for the Board.

Superintendent Lisa Carter reviewed her May report and told the Board about the ESSER III Grant that Sharon Center School will be receiving.

The two bids for the Air-Conditioning installation were reviewed:

Motion by Anne Vance/2<sup>nd</sup> by Amanda Thompson that the Sharon Board of Education accept the lowest qualified bid from Sav-Mor Cooling & Heating, accepting their net bid in the amount of \$1,094,000, with the sources of funding being:

ESSER II Grant Nonrecurring Account SCS 2021-2022 Budget ESSER III Grant Unexpended Funds from SCS 2020-2021 Budget

Motion carried by unanimous vote.

After further discussion, the Board was in full agreement that they would move forward with the motion without setting up a contingency fund.

There was discussion with regard to a Board retreat. Chair Doug Cahill suggested contacting CABE to have them suggest some topics that could be focused on. The general consensus was that fall might be the best time to schedule such a retreat.

Motion by Deborah Rathbun/2<sup>nd</sup> by Anne Vance to adopt Policy 4000.1 and Regulation 4000.1, with a "Preponderance of Evidence Standard" rather than a "Clear and Convincing Evidence Standard". Motion carried by unanimous vote.

There was a request for Early Release for students during the last week of school.

Motion by Deborah Rathbun/2<sup>nd</sup> by Anne Vance to approve a 1:00 p.m. early release for students on Monday, June 14 – Thursday, June 17 for professional work by staff. Motion carried with three yea votes (Cahill, Rathbun, Vance), one nay vote (A. Thompson), and one abstention (P. Petkov)

Motion by Amanda Thompson/2<sup>nd</sup> by Plamen Petkov to adjourn. The meeting was adjourned at 8:03 p.m. by unanimous vote.
