SHARON BOARD OF SELECTMEN

Draft until approved at the next regular meeting

A regular meeting of the Sharon BOS was held on April 13, 2021 at 3:00PM via ZOOM and in-person at Town Hall. Present were the three Selectmen, Barbara & Brent Prindle, Jill Drew, Matt Andrulis-Mette, reporter Hawken

First Selectman called the meeting to order at 3pm.

Mr. Jones made the motion to adopt the agenda, seconded by Mr. Flanagan, with all in favor.

Mr. Flanagan made a motion to approve the minutes from March 23, 2021 as submitted, seconded by Mr. Jones with all in favor.

Draft of the 2021/22 Five-Year Capital Improvement Plan was discussed for approval to the Board of Finance. Jill Drew provided information on the Sharon Broadband Task Force's request to include Broadband/Cell Service improvements on the list, noting current Federal Grant opportunities and shovel-ready status; Matt Andrulis-Mette provided information on the Sharon Parks and Recreation's ad hoc Community Center Renovation Committee's first floor improvement proposal and their reasons for wishing to include the project on the list. The list was updated and prioritized by year, as requested by the Board of Finance in 2020. Mr. Jones made the motion to approve the 2021/22 Five-Year Capital Improvement Plan to the Board of Finance, seconded by Mr. Flanagan, with all in favor.

The Sharon Fire Department's request for an additional 2021 fiscal year appropriation of \$6,474.48 to cover life insurance for SFD members was discussed. Mr. Flanagan made the motion to approve the request which was seconded by Mr. Jones, with all in favor.

The draft application for the Food Truck Ordinance was reviewed. A vote on the Ordinance will be made at the next Selectmen's meeting.

Social Service Agent resume due date of April 15, 2021 was noted. The interviews for this position will take place on April 22, 2021 at 5pm.

The 2021/22 request to Board of Finance for General Expenses at 67 Main Street was discussed. Mr. Jones made the motion to approve \$5,000 for general expenses for 67 Main Street, seconded by Mr. Flanagan, with all in favor.

A request from Pastor Robert Keay to use the Town Green for 2021's National Day of Prayer on May 6th was approved via motion by Mr. Flanagan, second by Mr. Jones, and all in favor.

The board voted to hold the 2021/22 Town Budget Hearing and Town Budget vote at Sharon Center School's Gymnasium on April 30th and May 14th. Both meetings will begin at 6:30pm. Motion to approve meeting location and time by Mr. Jones, seconded by Mr. Flanagan, with all in favor.

Community Update:

Mr. Colley met with Road Foreman, Jamie Reid, to discuss and schedule Town road improvements. Update on road improvement schedule will be provided in the next Town Newsletter.
