## SHARON HOUSING AUTHORITY SHARON RIDGE EXPANSION CORPORATION Draft until approved at the next regular meeting

A regular meeting of the SHA and the SREC was held on March 16, 2021 at 5:00PM at the Town Hall. Present were Chairman Colley, Treasurer Whelan, Vice Chairman/Asst. Treasurer Manasse, Secretary/Tenant Representative Moss and Commissioner Castonguay. Also in attendance was Site Administrator Broderick.

## PART 1

Mr. Colley called the meeting to order at 5:04.

Mr. Manasse made a motion to approve the minutes of 2/16/21 as written, seconded by Mrs. Whelan, with all in favor.

Ms. Broderick gave her Administrator's Report.

Mrs. Whelan reviewed the financial report. The February payments totaling \$6,612.21 were reviewed. Mr. Manasse made a motion to approve the payments, seconded by Mrs. Whelan, with all in favor.

There were no communications.

Old Business: Hopefully in a week or two the paperwork should come from Eversource to be signed for the loan. Cornwall Plumbing is all paid and these bills needed to be submitted to Eversource to complete the loan process. Water Systems is still owed money but this will be taken care of. Some funds from the Expansion will be used to pay Water Systems as this project affects both complexes. The loan from Eversource will cover all the costs – paying the bridge loans with Salisbury Bank & Trust Company as well.

New Business: None

## PART 2

Ms. Broderick gave her Administrator's Report. The tenant in 4-D is again requesting that her dishwasher be replaced. The Board discussed two options for Ms. Broderick to offer the tenant. Mr. Manasse made a motion that the tenant be offered: 1) authorize her to purchase a new GE dishwasher for \$376.09 and then be given a \$100 credit toward the rent to cover the cost of what replacing just the racks would be (net cost being \$276.09); OR 2) SHA purchase just the racks as the dishwasher does work. In the discussion it agreed that if the tenant opts to purchase the dishwasher, an agreement must be signed that the dishwasher remains when they leave. Vote taken on motion – carried unanimously. The same tenant asked to be able to put up a kind of blind on the back door window that requires drilling through the metal door – NO this would not be allowed. There are other options available for putting up some kind of shade or blind.

Mrs. Whelan reviewed the financial report. The February payments totaling \$8,477.28 were reviewed. Mr. Manasse made a motion to approve the payments, seconded by Mrs. Moss, with all in favor.

There were no communications, nor any Old or New Business. PART 3

Probably at the next meeting there will be a discussion on how the loans all fit together. There was a short discussion on grants that may be available to place picnic tables and grills in the common areas and replacing the playground. There was also a discussion on installing solar but the need for 3 phase electric cable could be an issue. This is a topic that the Sharon Energy & Environment Commission could look into.

With nothing further, Mrs. Whelan made a motion to adjourn, seconded by Mr. Manasse, with all in favor. The meeting was adjourned at 5:54.
