*(Required wording): "I move that Pursuant to C.G.S. Section 10-215f, the Sharon Board of Education certifies that all food items offered for sale to students in Sharon Center School, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2021, through June 30, 2022. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including the school store, the school cafeteria, and any fundraising activities on school premises sponsored by the school or by non-school organizations and groups."*

Food and Beverage Exemptions:

*(Required wording): "I move that the Sharon Board of Education will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards, and beverages not listed in Section 10-221q of the Connecticut General Statutes, provided that the sale is in connection with an event occurring after the end of the regular school day or on the weekend, the sale is at the location of the event, and the food and beverage items are not sold from the school store."*
