### GENERAL INFORMATION

The property owner must submit a written application for appeal hearing to the Board of Assessment Appeals so that said application is received by the board on or before **February 20, 2024**. Once the application is received and accepted a notice will be sent to the property owner with his or her hearing appointment date and time.

At the hearing the property owner should provide specific information to the Board of Assessment Appeals regarding the value of the property and the reason for the appeal. Some examples are: denial to build by a local land use board, or a recent appraisal as of the last revaluation year would be examples of information that could be provided to the Board of Assessment Appeals. Decisions regarding the hearing will not be made at this time.

Prior to taking any action, the Board may request an on-site visit.

The Board of Assessment Appeals may:

- Reduce the taxpayer's list by reducing the valuation
- Increase the assessment
- Add omitted property

The Board must reveal, in writing, the final determination of each taxpayer's appeal. This notification will be sent to you by mail. (§12-111)
